Present at meeting, Bartholomew, Lane, Bronson, Hartwell, Leonard, Flint, Emery, and Dodge. Mr. Bartholomew called the meeting to order, and Saml M. Lane was chosen Chairman, and A. J. The committee on rooms reported progress, through Mr. Flint.

Mr. Emery was instructed to take care of all books till otherwise ordered.

Library Committee met this evening at the office of A. J. Bartholomew.

Present, Lane, Flint, Bronson, Emery and Bartholomew.

The secretary reported a list of regulations for the government of the committee.

The following is the report:

Article 1. The Library Committee shall be organized annually, on the evening of the first Monday after the annual town meeting at which such committee is chosen, by electing by ballot, a chairman and a Secretary, and such officers shall continue in office until others are duly chosen.

Article 2. The Chairman shall, when present, preside at all meetings of the committee, and the Secretary shall keep a record of all proceedings, and have the custody of its papers, and make the annual report of the committee to the town. In the absence of either of such officers, others shall be chosen to act in their stead pro tempore.

Article 3. Regular meetings shall be held on the First and Third Monday evenings in each month, at 7½ o'clock, at such place as the committee shall appoint. Special meetings may be called by the chairman, or secretary, either at their own will, or upon the request

of any two members of the committee.

Article 4. Members shall be notified of all special meetings by personal notices, or by notices in writing, sent to them previous to the time appointed therefor.

Article 5. A majority of the committee shall constitute a quorum for the transaction of business.

Article 6. No books, periodicals, papers, or other reading matter shall be procured for, or admitted to the Library without the approval of the committee.

Article 7. The standing committees of the board shall be four, to consist of three members on each, as follows:

An Executive Committee;

A Committee on Finance;

A Committee on Books;

A Committee on Library.

Such committees shall be chosen each year from the members of the board; and they shall perform such duties as may be assigned to them, subject always to the general direction of the full board.

Article 8. The committee may also make such further rules as it may find necessary for the proper discharge of its duties.

The foregoing articles were adopted by the committee.

The committee on rules for use of Library reported that it was inexpedient to adopt any rules until the opening of the library to the public. Report accepted.
