Voted, to add the builder's edition of the "Scientific American."

Voted, that the "Missionary Review" and "Biblical World" be dropped. Voted, to take magazine "Recitation" one year.

Voted, to accept the present magazine list with the corrections voted this morning.

Voted, that the matter of the French magazine be laid on the table.

Voted, to accept list of 25 books compiled by
Miss Stanley.

Voted, to purchase six chairs for the Library.
