Mr. Cheney's report was read
and accepted, as follows:

Except as hereinafter
provided, any new applicant for the
privileges of the library shall deposit
with the librarian the sum of two
dollars, said sum to be returned to
the applicant when it has been
shown to the satisfaction of the li-
brarian, or her representative, that
the applicant has been a resident
of Southbridge for not less than
six months.

In lieu of the deposit of
two dollars the applicant shall
sign a form of the general charac-
ter described below, which when duly
signed by the applicant and
vouched for by some responsible
citizen of the town shall entitle the
applicant to the privileges of the li-
brary. Form - The undersigned
hereby makes application for him-
self, or herself, and family, for the

privileges of the Southbridge public library, including the taking out of books. He (or she) hereby agrees to abide by the rules and regulations of the library and to be personally responsible for all books taken out.

Vouched for

The above requirements may be waived by the librarian at her discretion in the case of persons known by her to be responsible for an amount equal to the value of books taken and otherwise worthy of the privileges of the library, but such names shall be reported to the Library Committee at its next meeting.

It was voted that meetings during July and August be called if necessary by Secretary.

Voted that Mr. Grant be given the contract to print the French catalogue at price submitted.

Voted that we purchase the list of books presented at meeting.

Voted that Librarian have printed one thousand forms for applicants who wish to take out books.

Voted to adjourn at 8.30 p.m.
